DIRECT LINE left the first turn widest, came in near the nine sixteenths pole, settled off the pace in mid track the remainder of the backstretch, split horses four wide leaving the quarter pole, came in a path at the three sixteenths pole and dug in determinedly for the lead just inside the sixteenth pole. MY MAMMY stalked the pace two deep, took aim three wide leaving the quarter pole, came in a path midstretch, dueled with a slim advantage and held on gamely for place while outfinished for the win. DR. JESS JR stalked the pace about the three path, was carried five wide approaching the quarter pole, dueled close in the stretch and finished well though was outfinished for place. LITTLE HARBOR rated off the pace inside, was boxed on the rail at the heels of Coffee Creek Honey through the final turn, dueled close into the lane but yielded near the sixteenth pole. SPRIG OF LILAC was carried inward leaving the first turn and pinched back near the nine sixteenths pole, settled into stride the remainder of the backstretch, angled seven wide leaving the final turn and bid mildly into the lane. RIVETING, unhurried outside, bid mildly six wide on the final turn then leveled off through the lane. AMNESIAN rated back two deep, steadied at the heels of Direct Line past the half mile pole, was shuffled back at that one's heels again at the three sixteenths pole and gave way from there. FULL OF IDEAS saved ground. COFFEE CREEK HONEY rated the pace inside, pressured for run into the final turn, pinched back midstretch and gave way from there. DREAMS INCLUDED never factored. After reviewing two claims of foul where the rider of Sprig Of Lilac alleged foul against the winning rider and the rider of Coffee Creek Honey alleged foul against the rider of My Mammy, the stewards declared this race official without change.
