**Footnotes**

COASTAL SOLACE led inside the opening turn, stalked the pace off the rail down the backstretch, was eased four wide making her bid midway on the final turn, dueled to the lead midstretch and inched clear toward the wire. STAR SNUCK rated off the pace three wide, moved to the lead passing the three eighths pole, dueled with a slim advantage through the top of the lane then gradually ceded to the winner. ROUGH WATER rated off the pace inside, bid toward the five sixteenths pole to take a brief lead in the upper stretch then weakened nearing the eighth pole. TALE OF THE DIVA, five wide the opening turn, rated the pace to the final turn, was pressured for run toward the three eighths pole then dropped back from between horses while weakening approaching the quarter pole. SERRANO DEL SOL rated off the pace about the three path, gave chase through the final turn then weakened in the stretch. MAY WE DANCE, CIMMERON SUE and STIRRUP CUP were never factors.
