Footnotes

TEN BELLS stalked the pace off the rail, made a three wide bid into the final turn, dueled to the front toward the quarter pole and dug in under a determined drive to inch clear approaching the wire. MINUTE rated well back saving ground the opening half mile, advanced nearing the final turn, took aim at the quarter pole and dug in gamely to deep stretch before reluctantly yielding. DANGER ANGEL rated back off the rail, closed toward contention approaching the final turn, eased four wide into the lane and finished evenly. PERFECT QUATORZE stalked the pace about the four path, bid into the final turn, was at even terms four wide near the quarter pole but leveled off through the stretch. FIVESIXSEVEN took inside position approaching the first turn, rated the pace off the rail, was pressured through the final turn then dropped back weakening into the lane. INSATIABLECASANOVA was outrun toward the outside. SHEPHERD ONE stalked the pace off the rail then had no response on the final turn. WILD COURT, off the pace about the three path, had no response saving ground on the final turn. T. J.'S REVENGE was not a factor. GEME DE LIGHT steadied early and never factored.
