Footnotes

RAIKKONEN lacked early speed, improved position six wide on the turn, closed steadily through the stretch and got up the final yards. TRUST OF HONOR advanced to the lead along the rail past the half mile pole, was pressured from the three eighths, maintained the advantage under steady handling to deep stretch then outfinished the closing yards. DOMESTIC CIRCLE chased the pace from the outside, came through the turn five wide and finished well. RAYBERN'S GOLD stalked the pace off the rail, took aim passing the five sixteenths pole, lost a lane leaving the turn then leveled off in the stretch. WET 'N WILD CAT showed no early speed outside, saved ground making a bid into the turn then leveled off through the lane. MR. BRAGGADOCIO gave close early chase in mid track then faded through the turn. MIDASWELLFLY drifted outward on the turn and was bumped entering the stretch. JUDGE WELL stumbled after the start. AUSTRALIS EXPRESS chased the pace off the rail, faded through the turn, bore out bumping Midaswellfly leaving the quarter pole and gave way from there. QUEENS PARTNER rated a slim lead about the three path before fading on the turn.
