**Footnotes**

OUTER DRIVE moved to the rail after the start, set the pace inside, repulsed a strong challenge on the final turn and edged away. TAKE DOWN TWO eased out slightly rounding the first turn and he had his heels clipped, stalked the pace outside winner, challenged on the final turn but then was no match. Following a stewards inquiry, TAKE DOWN TWO was disqualified and placed last. REFLECTED WAY saved ground and failed to menace. PROUD MCKEE hurdled fallen rider on the first turn. CENTURY JET failed to menace. SMASHING EXAMPLE bore out through the stretch and was being eased. SON OF SLAM forced out slightly first turn, stopped badly. TSUNAMI STRIKES was in tight entering the first turn, clipped a rivals heels and unseated his rider soon after.
