FIVESIXSEVEN moved to the lead entering the turn and drew off after a half mile then was not good enough in deep stretch. BONA FIDE (ARG) was away in good order then finished best of the others. SAL'S BOY failed to be a threat. SPICE TREE lagged behind to the stretch then failed to be a threat with a late bid. PICOPICO TIME chased the leaders for a half mile then had little left. ACHILLES QUEST tired. WELL CALL ME led for 3 1/2 furlongs then faltered.
