RED SAIL AT SUNSET moved up menacingly three wide on the far turn then lacked the needed stretch response. HOMER moved up along the inside rail into the stretch to gain the show. FRIAR stalked the pace then lacked the needed stretch response. BROOKSBY raced within striking distance but lacked a solid rally. VIENNA HILLS disputed the pace racing two abreast then weakened in the drive. PARK AVENUE showed little. YO SLICK tired.
