YOU ASKED was well placed close to the pace, circled four wide around the far turn to challenge then was ridden out to draw off. PHILLY GAL moved up along the inside on the far turn then was no match for the winner in the stretch. SHE'S FANCY FREE disputed the pace racing three abreast and gave way grudgingly. BLUSHING SKIER was unhurried early then responded well in the drive. WHO'S HAPPY lacked a solid rally. TAZALIYA broke alertly to contest the pace then weakened in the drive. STAR SNUCK prompted the pace, was checked sharply in tight quarters leaving the far turn then drifted out into rival in upper stretch. JENNY BEAN GIRL showed little. A claim of foul by the rider of SHE'S FANCY FREE against the winner for interference near the three furlong grounds was not allowed.
