ARLENE'S PRIDE had early speed to set the pace,continued on gamely but was outfinished. DAZZLED SAINT settled in good position,closed willingly. CHIEF COMPLAINT bumped with EURO GHOST soon after the start,saved ground,lacked a late response. OFF THE GREEN raced wide, lacked a late rally. SONNY'S MEMORY had no excuse. HORRENDOUS was void of early speed,ducked in at the top of the stretch bothering EURO GHOST then had no rally. EURO GHOST bumped with CHIEF COMPLAINT down the backside, was bothered again on the on the turn losing all chance. MAX'S KITKAT trailed.
