ANOTHER SENOR vied inside and prevailed late under a steady drive. PAY THE JUDGE vied outside the winner but was outfinished. BUCKY was off awkwardly, then bid belatedly five wide. PIE TOWN bid belatedly four wide. HIDDEN POWER bid four wide at the three-eighths pole, then faltered in the drive. RONIN JUSTICE saved ground to no avail. TUTANKHAMUN stalked the pace three wide to the stretch before giving way. HOMETOWN was not a factor.
