GIBSON bumped with a rival at the start, dueled inside of that while off the rail, bid at the three-sixteenths pole to be clear and drew off while ridden out for the win. LION'S REIGN saved ground, bid at the eighth pole, then couldn't match strides with the winner. NO PAPARAZZI stalked the pace four wide, then improved position late. WILD ALLEY CAT bumped with the winner at the start, dueled outside of that one, then gave way in the drive. SEYMOUR OF STEVE stalked the pace three wide, then faded in the drive. FOOTMARK saved ground to no avail.
