CRIMSON DOON pressed the early pace, bid at the eighth pole, lugged out eight wide in the stretch despite the right-handed whip and drew off in the drive. PEAKABOO I C U stalked the pace three wide, fanned out seven wide in the stretch, but lacked a late bid. REGINA'S WISH improved position late while four wide. EVERY LITTLE THING stalked the pace three wide, but lacked a late bid. BERRY DELIGHTFUL led for a half mile, dueled inside, then gave way in the drive. CUYAHOGA RIVER saved ground, then faded in the drive. ROYAL VESSEL was not a factor.
