RONIN JUSTICE stalked the pace three wide, bid at the quarter pole and was clear late under a mild drive. FARMHOUSE stalked the pace inside, angled out four wide in the stretch but had no late bid. PAY THE JUDGE had a mild late bid while six wide. COMING HOME SOON stalked the pace between rivals, then lacked a late bid. JOVIAL MAN stalked the early pace, bid at the quarter pole, then faltered late. THE A. TRAIN raced four wide. COOS BAY dueled inside, then gave way stretch. BAD NEIGHBOR was not a factor. ANYONES GAME saved ground to no avail. CHIEF INSPECTOR raced five wide. MAKINSPARKSFLY dueled to the turn before giving way.
