IN MY CORNER had speed from the start three wide, responded with a quick move on the turn, opened a daylight lead while setting the balance of the pace and won under strong handling. CAPITOL APPEAL never far back, offered a bid two wide into the stretch and gamely gained second. VITAL ARGUMENT allowed to settle, advanced steadily four wide. PEACEFUL SLEWTION sprinted up along the rail the opening quarter, steadied before the turn, angled four wide, dropped back towards the inside through the stretch and finished willingly. FLIRTTHENET inside, failed to menace. SHADY ED had brief speed. PUTITALLTOGETHER bore in at the start, set the pace into the turn then stopped. WHO WRAY trailed.
