MAGGIE'S PLEASURE stalked the pace just off of the rail, angled out three wide in the stretch, rallied and held off the closers under an all out drive. CUTIE GIRL was quickly over to the rail, saved ground around the turn, was steadied at the quarter pole in tight quarters, rallied in the stretch and came out three wide for running room, was steadied again late to avoid heels, bid and missed. L D'S GALAXY raced three wide, angled out seven wide in the stretch, rallied and missed. JUSTICE DENIED stalked the pace between rivals, rallied four wide, lugged out late and missed. MOON OVER PARADOR saved ground, was looking for room in the early stretch, then got out four wide for a belated rally. PASSION POINT was clear early but couldn't hold off the closers. WINGED BANDIT stalked the pace three wide, then faded five wide in the drive. ARKY SPRING'S was off awkwardly, stalked the pace to the stretch, then gave way.
