U. S. S. GOLIATH up close early while inside rivals, gained the advantage entering the turn, opened a clear margin at the eighth pole and was clear late under steady urging. CRAFTY MATCH stalked the early pace from the outside, advanced entering the turn, responded to pressure but could not reach the winner. SCOTTIE never far back while outside rivals, inched closer entering the turn, dropped inside for the drive and finished well but too late. TOKEN DEM duelled from the outside and tired. THRESHER forced the early pace inside but had nothing left. MR. BUCKEYE was no factor. BURNING ELEMENT duelled from the inside and gave way.
