### Footnotes

POP TARRT was settled in the early going then moved out to be outside heading into the far turn, rallied five wide at the top of the stretch, was in a strong drive on the outside then drew off in late stretch. APPALACHIAN TRAIL was well placed while racing four wide on the backstretch, rallied four wide on the far turn and was in a long sustained drive but hung in late stretch. DUGAN was pressing the early pace while three wide on the backstretch, made a move to challenge for the lead before the far turn then dropped back on the far turn, came again in late stretch to finish well. FINAL JUDGEMENT dueled for the early lead while two wide, was in a long sustained drive while inside in the stretch but tired in deep stretch. BISHOP CASEY was inside on the backstretch and saved ground on the far turn then swung out to be five wide in upper stretch and made a mild gain in late stretch. DEVIL APPROVED IT was unhurried early then swung out to be seven wide in upper stretch and was no threat in the stretch. SHADY ED was angled inside on the first turn to be two wide, was then settled while three wide on the backstretch, rallied three wide on the far turn making a bid then faltered in the drive. MYSTICAL MOUNT dueled for the early lead while inside, was used up and stopped in the stretch.
