**Footnotes**

SAINTLY SOLUTION led inside, turned back a challenger at the eighth pole to be clear and then held off the closer under a steady drive. ROAR AS THE WYNNND saved ground, angled out four wide at the three-sixteenths pole, then rallied belatedly. HALF A WELL stalked the pace four wide, bid at the quarter pole, then faltered late. LISCANNOR BAY pressed the pace, then gave way in the stretch. GHOST CHAPEL bore out at the top of the stretch, bumping two rivals, then failed to menace. After a stewards' inquiry and an objection by the rider of GEONI he was disqualified and placed seventh. HAIDUK was bumped in the hindquarters at the top of the stretch and then lacked a late bid. GEONI stalked the pace three wide, then was taken up when knocked sideways at the top of the stretch. TEENAGE DISTRESS pressed the pace three wide for a half mile before giving way.
