**Footnotes**

UNIQUE INCIDENT dueled for the early lead while inside and under good handling, drew off in upper stretch and was kept to task in late stretch while proving best. FASTER THAN FLASH moved up heading into the turn to duel for the lead, was in a long drive but was no match for the winner in late stretch. SOOTHING WIND chased the early pace while racing on the inside on the turn, made a bid then raced evenly in the stretch. AL NASR'S PRINCE was unhurried early then saved ground on the turn and moved up in late stretch but was no menace. CORUSCATION was settled on the turn then made a bid and swung out to be five wide in upper stretch but failed to menace in late stretch. I'M KATALAKIN raced four wide on the turn, made a bid to mid stretch but flattened out in the end. KINKY RULE raced five wide on the turn and was no factor. WORTHMORETHAN MATT raced six wide on the turn and was no threat. WIT SPEED TO BURN broke through the gate when loading and ran off for three furlongs, was reloaded then showed brief foot while inside and stopped.
