PAY THE JUDGE was off awkwardly, stalked the pace four wide, bid at the five-sixteenths and was up late under strong urging. MY KNIGHT INDEED saved ground early, lacked running room at the top of the stretch, angled out five wide, rallied but missed at the wire. STRONG STAND stalked the pace three wide, bid at the quarter pole, dueled late but was outfinished. KLONDIKE EXPRESS saved ground, bid at the quarter pole, then faltered late. MO' TERMS was unrushed early, then rallied belatedly. FOOTMARK led inside before giving way in the drive. MISTER SHANAHAN pressed the pace three wide before giving way in the drive. VICTORY ISLE pressed the pace between rivals for a half mile.
