INTERROGATE raced three wide, bid at the quarter pole, dueled briefly, then drew off under steady urging. PLUS ONE raced four wide, bid in the stretch but was no match for the winner. SHE'SMYLITTLEMAN was bumped and squeezed back at the start, then offered a mild late bid four wide. CORSICA bore out at the start to bump a rival, dueled inside to the stretch and gave way. HONEY BUNCH saved ground to no avail. SWEET TIA and PERFECT BELLE were not factors. FREEDOM LAND dueled outside of the leader before giving way in the drive.
