**Footnotes**

COCOA'S IMAGE pressed the pace outside of the leader, dueled through the stretch and was clear late under a mild drive. RADIANT SKY was clear early inside, dueled through the stretch and yielded late. CHERRY WILDCAT stalked the pace inside, bid at the quarter pole, then gave way late. IMVROS IMAGE improved position late between foes. UNSPOKEN CODE pressed the pace between rivals, angled out five wide in the stretch but had no bid. NEWFOUND STAR raced evenly four wide. SARAYU improved position late eight wide. KATY'S CUPCAKE raced evenly inside. REINE DE BONBON and RUNWAY TWIGGY were not factors.
