WICKED SMOKIN FAST stalked the pace between rivals before giving way on the turn. EASY SAILING and MORNING CIGAR improved positions late outside. YOGOTTHATGOINFORU stalked the pace, hit the rail at the half and the seven-sixteenths poles, then gave way. OFFICER'S DUTY hesitated at the start. PROWERS COUNTY was through early three wide.
