**Footnotes**

KAY WAR stalked the pace five wide, bid at the five-sixteenths pole, drifted out in the stretch, was carried out late and was up late under steady drive. MY SOUL SISTER was clear early, lugged out in the stretch and was outfinished. SONG FOR PUPCAKE rallied six wide on the turn, then drifted out in the stretch. SKIP TOO WIN bid three wide on the turn but hung in the stretch. IMVROS IMAGE saved ground to no avail. DENALI TIZAWINNER pressed the pace inside, but faded in the stretch. ISABELLA BELLA improved position late seven wide while drifting out. TUOUBLIERASMONNOM pressed the pace between foes before fading in the drive. ATSHERRYSBAR stalked the pace four wide, bid at the quarter pole but faltered in the drive. ROSAMONTE stalked the pace between foes before fading on the turn.
