DIXIE SHEA raced off to a well rated, clear lead entering the turn, widened when called upon in upper stretch and just held while weakening in the final hundred yards. U. K. GIRL tracked the pacesetters into the turn, moved three wide to a striking position at the top of the lane and was closing fast to just miss. MAC N MAYO reserved off the leaders to the quarter pole, swung five wide into the lane and finished well on the outside. STORMY DEEDS pressed the pace to the quarter pole and weakened in the final eighth. SHANANIE'S HONOR rated off the pace and mounted a mild rally in the lane. HOT GOLD stalked the pace from the rail to the head of the stretch and faded in the drive. SUPERTUNIA posed no threat. SAILORS PASTTIME reared at the start spotting the field eight lengths and trailed as a non-factor.
