RYAN'S GIFT pressed the pace outside of the leader, bid at the eighth pole, dueled late and was outfinished. PYRITE PERSONAL led inside, then gave way late. MOTION TO APPEAL saved ground to no avail. UNION BOWMAN stalked the pace three wide, then lacked a late bid. CRYPTOLIGHT stalked the pace between foes, then faded in the stretch. FLEET BEAT was not a factor.
