DELTA LADY angled out four wide at the quarter pole, bid but was no match down the lane. BLACK JACK GIRL improved position late four wide. TEN PLEASURES dueled before giving way late. TAYLORS SWEETHEART improved position late between rivals. PERFECT REVELATION pressed the pace three wide before giving way late. JABEZ dueled before giving way late. ELLIES TEXTBOOK faded. OUT BY TOMORROW was not a factor. BELLAMY LASS faded. ICE NEEDLE was not a factor.
