S W IAN bid four wide at the quarter pole, then was clear late under a mild drive. REJECTED was quickly over to the rail, was clear early but couldn't last. RON BURGUNDY saved ground, then had a belated rally while five wide. BARBERSHOP stalked the pace six wide, then had a mild late bid. RAFAEKI improved position late eight wide. GO BRAY BOO raced evenly four wide. OFFICER MOO LA MOO chased the leader inside, then gave way. CRAFTY NOBLE was not a factor. DUTYHONORCOUNTRY hopped at the start. WILD PEGASUS faded.
