PAY THE JUDGE unhurried while settling three wide, angled out five wide on the second turn, surged quickly to the lead entering the stretch then proved best in a prolonged drive. THE CUFF SHOOTER hopped a bit at the start, was outrun for a half, moved up quickly just behind the winner, drew on near even terms with that one before mid stretch, matched strides to the wire but finished second best. TIGER TWIN settled mid pack, offered a bid six wide into the stretch then finished evenly. BROTHER BRETT outrun for five furlongs, had a mild late rally seven wide while no threat. SPURIOUS settled just off the leaders into the second turn, drew closer nearing the quarter pole then came up empty. JACK SAW well placed, failed to offer a closing response. WOODYS A GOODIE was outrun. MR. RAVEN was through after six furlongs. GENTLEMAN CALLER pressed the pace three wide for a half, made the lead, set the pace until the top of the stretch then flattened out. DUE D' TOUR away alertly, set a pressured pace for a little over a half then stopped. MY CAT CODE offered little.
