TWEAKIN stalked the pace from between horses,moved up and bore in on the turn bothering rival, rallied to gain command and held well under pressure. EXCHANGEABLE was unhurried early,had a steady advance,was forced to check sharply on the turn from between horses,dropped back,finished well to gain the place. GETTHELASTWORDIN was away alertly,dropped in bothering rivals,opened a clear lead,shortened stride and weakened. HEAVENLY BREW had good position,made a middle move, needed more. CHESAPEAKE DANCER chased the leaders, faltered. FLOWERS BY DAY was shut off at the start, showed little. GREATER REWARDS pressed the pace, faded. SWEETSOUTHERNWAY was no threat. MARLO'S CLOCKET trailed and was eased when hopelessly beaten. The rider of EXCHANGEABLE claimed foul on the winner TWEAKIN for alleged interference on the turn and the rider of FLOWERS BY DAY claimed foul on GETTHELASTWORDIN for alleged interference leaving the gate. After review the stewards disqualified TWEAKIN and placed her second and disqualified GETTHELASTWORDIN and placed her seventh
