BARTLETTS led between rivals and held sway under a mild drive. DEAL MAKING saved ground, angled out four wide at the three-sixteenths pole, bid but couldn't get to the winner. PYRITE PERSONAL stalked the pace between rivals, then lacked a late bid. RONIN JUSTICE was away slowly, then improved position late while three wide. CRIMSON KNIGHT pressed the pace four wide, then gave way late. WEAR THE CROWN pressed the pace inside to the stretch and then gave way. SHORE DO was not a factor.
