### Footnotes

PENNIES APPEAL gained a good early position just off of a three way pace battle, was put to solid hand urging mid turn, rallied four wide through a seam entering the lane, forged to command under left handed pressure in mid stretch, edged clear and held firm. KINGINTHECITY tracked the pace while travelling just outside the winner, had to steady off the heels of HOW FAR WE'VE COME when that one drifted out entering the stretch, regrouped, shifted out some and finished up gamely to cut into the margin. CHICKAMAUGA, off the pace between rivals, altered outward inside the eighth pole and rallied between rivals. SPINNING LADY set a pressured pace towards the inside, raced off the rail in upper stretch and gave way grudgingly. AWESOME FLOWER, in close at the break, picked up momentum while circling very wide into the stretch, brushed with HOW FAR WE'VE COME, raced on her left lead late and flattened out. DANCING ANNA vied between rivals, took a short lead into the lane, battled inside the winner leaving the eighth pole then faded. HOW FAR WE'VE COME disputed the pace four wide, drifted out entering the stretch and faded. DIAL DIRECT saved ground, made a slight run nearing mid stretch then flattened out.
