ARCTIC RAVEN broke slowly, was five wide the first turn, moved up four deep leaving the backstretch, dueled outside TODAY'S MAN, drifted in under right hand whipping near the sixteenth pole and held sway. VALENTINO'S BOY broke slowly when swinging his head to the right at the break, rushed up five wide the first turn, chased the pace, drifted very wide tuning for home and finished willingly. COUNT ON LOU saved ground, chased the pace and lacked the needed late response. TODAY'S MAN , three wide the first turn, set the pace inside foes down the backstretch, was challenged on the far turn, dueled to midstretch and gave way after being steadied on the heels of ARCTIC RFAVEN near the sixteenth pole. SYMPHONIC HERO hesitated at the break, rushed up in the two path on the first turn, chased the pace and gave way. MY PIANO MAN , wide the first turn, was pulled up lame entering the backstretch. An objection by the rider of TODAY'S MAN against the winner for alleged interference in the stretch was not allowed.
