AGELESS quickly established command, set a rated pace off the inside, was guided out further into the track in upper stretch, responded well to a few taps inside the eighth pole, eagerly widened and won under minimal hand encouragement. SNOW FLURRY , between rivals early, angled to the inside early turn, edged closer into the stretch, continued on willingly while no match but did gain the place. PENNIES APPEAL prompted the pace outside the winner, was put to a full drive giving chase in upper stretch, failed to match strides and faded late. KINGINTHECITY lost ground four to five wide and failed to respond. PREACH EASY settled off the rail, came three to four wide for the drive and had no rally. CHICKAMAUGA stalked the pace between rivals, was put to strong urging mid turn and weakened. ASPEN BLUSH saved ground and weakened.
