Footnotes

OVER AND ABOVE , a forward factor in the two path, drifted in and bumped UNBRIDLED MAGIC near the sixteenth pole, brushed with that one near the eighth pole and again near the finish. UNBRIDLED MAGIC set the pace along the rail, opened up on the far turn, was bumped by the winner near the three sixteenths pole, brushed with that one near the eighth pole, again near the finish and fought it out gamely to just miss. CARLINGFORD , bumped leaving the starting gate, raced three wide on both turns, drifted out in upper stretch and rallied mildly. PERFECT NEUVIEME , rank entering the backstretch, saved ground, advanced along the rail to the five sixteenths pole and raced evenly through the stretch. DONA CARMELA saved ground the first turn, circled the far turn and gave way through the stretch. SALUKI SHOWTIME drifted out leaving the starting gate and was all done on the backstretch. DEE BOMBA trailed. An objection by the rider of UNBRIDLED MAGIC against the winner for alleged interference in the stretch was not allowed.
