MALIBU MOON DANCE , bumped at the break, stalked the pace off the rail, moved three wide to challenge nearing the quarter pole, assumed command entering the lane, kicked well clear under right handed pressure in mid stretch then maintained a safe margin under a drive. ALLEGHENY MOON rated within range while saving ground, shifted out leaving the eighth pole and finished with good energy. VESTED IN TOWN broke sharply, set a pressured pace inside, dueled nearing the quarter pole then faded in the final furlong. MIDNIGHT DANCING bobbed then was bumped at the break, was urged along off the rail, came five wide for the drive and had some belated action. TOTOLOCHEE rushed up to contention soon after the break, pressed the pace two wide, dueled between rivals nearing the lane then weakened in the final furlong. TRUFFLE SHUFFLE came in at the break, chased the pace three wide and came up empty. MADALYN'S CHOICE flashed speed inside, shifted out for the drive and failed to threaten. FULL OF FLASH was steadied nearing the half mile marker. An objection by the rider of MIDNIGHT DANCING against the winner for alleged interference leaving the gate was not allowed
