**Footnotes**

CASE OF THE BLUES was unhurried early, moved a bit closer around the final turn, swung very wide for the drive, closed determinedly under pressure and was up in the final yards. FOR MONEY angled to the rail around the first turn, set a slow pace along the inside, drew well clear in mid stretch, held well but could not withstand the winner. BLUSHING BROAD stalked the pace three wide and lacked a solid response. OUT WITH IT steadied back off of FOR MONEY around the first turn, stalked the pace two wide and faded. SNEAKS weakened. An objection by the rider of OUT WITH IT against FOR MONEY for alleged interference around the first turn was disallowed.
