HIGH APPEAL rated close up behind a contested pace, angled out four wide near mid stretch, forged to command inside the sixteenth marker and proved best under a drive. CUDJO stalked the pace three wide, lodged a bid nearing the quarter pole, gained a slim advantage in mid stretch, dueled and continued on gamely. GOLD IS MINE prompted the pace two wide, lodged a bid between rivals around the turn, dueled past the eighth pole and gave way grudgingly. COPELAN'S RIDGE cleared early, set the pace inside, was joined nearing the lane, dueled to mid stretch then weakened a bit. CAP' N JACK saved ground, was steadied back nearing the turn, shifted out some late and was outfinished. TRICKY START was rated back after an alert start, came three wide for the drive and lacked a rally. HEFTY RETURNS bobbled then steadied at the break. BEARZAVA , three to four wide, faded.
