Footnotes

MONTANA STORM broke outward, bumped with LAWYER DAVE soon after, moved up four wide entering the turn and tracked the dueling leaders, bid under a light hold past the five sixteenths marker, dueled outside of LE TRICHEUR from the quarter pole to mid stretch, edged clear a sixteenth out then lasted under a drive. LAWYER DAVE , soundly bumped early, rated back between rivals, commenced a run leaving the three eighths pole, circled four wide into the stretch, moved up to take aim off the duelers in mid stretch but could only slowly gain in the final seventy yards. LIGHT OF MY LIFE , bumped and steadied in a jam up leaving the gate, settled back while saving ground, swung out with three furlongs to go, came six wide for the drive and closed willingly. LE TRICHEUR dueled two wide through a brisk opening quarter, took over around the turn while still within himself, was joined from the outside after a half mile, battled inside the winner to almost the sixteenth pole then gave way grudgingly. GRAY DOWRY bore out at the break causing crowding, rushed up two wide near the half mile pole then brushed with PHOTOGENIC, chased off the rail around the turn and weakened. AIM TO WIN was sent up inside rivals to take a short early lead, vied through a sharp early pace then succumbed before going a half mile. PHOTOGENIC saved ground, was brushed near the half mile pole, shifted out in upper stretch but lacked a rally. PARTY PRINCE hopped at the break and failed to menace. MASTER OF HUMOR , roughed up at the break, raced far back to upper stretch, saved ground through the lane and had belated action. RASPICUI broke inward, chased off the rail and faltered.
