ACCOUNTANT'S DREAM lacked speed, raced along the rail entering the stretch, swung out approaching the eighth pole, closed and drew off under brisk urging. SHORE GIRL set the pace, opened up on the far turn and tired in the drive. GAEBEL'S GAMBLE raced well off the rail in an even effort. GEE'S BEND lacked speed, was steadied on the heels of a rival near the three eighths pole, swung wide and rallied mildly. RIDE THE WILD WIND raced wide and weakened. LADY SPOTSWOOD was no factor. HANAILEI BAY raced along the rail, chased the pace and gave way. PASTEL was outrun. JUSTWANNABELOVED, three wide, chased the pace, stopped and was eased.
