### Footnotes

SKELETON CREW broke a step slow, angled in early and was taken to rate three wide off the pace, advanced between rivals into the lane, swung out six wide, closed sharply under mild right handed pressure and caught WHAT A PRINCE in the final yards. WHAT A PRINCE rushed up outside to put a head in front nearing the turn, alternated for the lead outside STONE IN LOVE, regained command a furlong out, finished gamely but could not withstand the winner's charge. STONE IN LOVE broke on top, dueled along the rail, held a short lead into the lane, was headed nearing the furlong pole, continued to battle past the sixteenth pole and stayed on well. PORONUI stalked the dueling leaders off the rail, came three wide for the drive but lacked a solid finish. COOPER COUNTY, three to four wide, was under a ride around the turn but failed to menace. SEEYOUINTHECITY failed to menace. MACH THREE lagged well back to the head of the lane then failed to generate the needed kick. NATURAL SEVEN saved ground stalking the dueling leaders, failed to respond when called upon in upper stretch and faded.
