PETER'S CREEK stalked the pace outside CITIGAMBLER, overtook that one entering the stretch, opened up under brisk urging in midstretch then increased his advantage late. SIR DUNCAN stalked the pace, circled the turn and gained the place. SHAMSS lacked speed, saved ground around the turn, swung outside in midstretch and rallied. CITIGAMBLER, quickly clear, set the pace along the rail and weakened the final furlong. RIGHT OF WAY was outrun.
