SIR DUNCAN broke sharply, dueled inside of CARSON CITY DUDE while under confident handling, disposed of that once mid turn, opened up a commanding lead when shaken up in upper stretch then was kept to mild hand pressure through the final sixteenth. SHOOKSTOWN ROAD , content to lag back early, angled out near the three eighths pole, circled four wide into the stretch and finished with good energy though no threat to the winner. CARSON CITY DUDE broke outward then was sent up soon after to poke a head in front near the five eighths pole, maintained a short lead dueling outside SIR DUNCAN a half mile out, continued to duel past the three eighths marker but could not match strides from there. SKIP THE TRIAL saved ground chasing the dueling leaders, made a slight advance nearing the lane but lacked a stretch response. CALL ME DUDE , off the rail, failed to keep pace and retreated.
