OFFICIAL AFFAIR chased the pace outside PLATTE RIVER, overtook that one inside the eighth pole then drew out under brisk urging. PLATTE RIVER accelerated to the front, set the pace along the rail, failed to hold off the winner and held the place. HEROS IMAGE saved ground, eased out in midstretch, rallied between horses and was lame galloping out. PRINCE NOIR stalked the pace, drifted wide leaving the turn and failed to rally. DUKE SKYWALKER saved ground and failed to rally. SUPER NEKIA circled the turn and weakened. CAPTAIN BRY , very wide in upper stretch, gave way. PATRICK N DYLAN was not a factor. DISTINGUISHED was outrun. WAR ACTION trailed.
