Footnotes

MORAL HIGH GROUND lacked speed off the rail, swung to the six path near the three sixteenths pole, closed outside horses and was up in time. PAUPER'S QUEEN, wide the far turn, floated to the five path entering the stretch, bid for the lead in midstretch then hung. MY QUEEN hugged the rail, challenged for the lead in midstretch then flattened out. LAUREL'S LANDING, three wide both turns, chased the pace to upper stretch then failed to sustain her bid. VIOLETTE BONBON prompted the pace outside STOLLEN and gave way the final furlong. STOLLEN saved ground setting a pressured pace, drifted to the two path turning for home then gave way. CONTROLLED NEGLECT chased the pace two wide and faltered entering the stretch. ALOOF was outrun. SHE'S FROM MONEY saved ground and dropped back after a half mile.
