SQUABBLE , clear entering the first turn, set the pace near the rail, was set down approaching the eighth pole and prevailed while kept to her business. THUNDERING ROSE save ground in a forward position, chased the winner through the stretch, drifted out in midstretch and finished willingly. DIXIELAND MELODY lacked speed, raced in the two path through the stretch and finished willingly. PINK SAND stalked the pace, circled the far turn, was floated wide entering the stretch and weakened. MAC SPEED , fractious in the post parade, raced wide leaving the far turn, was very wide in upper stretch and failed to be a factor. LILY QUATORZE prompted the pace outside the winner, drifted out entering the stretch and faltered. ALPHA DARLIN was outrun. ARMSGLEN was outrun.
