Footnotes

PRIMARY WITNESS , well rated, raced wide around the far turn, bumped with NO MESA WITH ME when challenging for the lead near the three sixteenths pole, dueled with KURBAT the final furlong and narrowly prevailed. KURBAT (CHI) chased the pace outside RASCAL CAT, bid for the lead midway on the far turn, lightly bumped with NO MESA WITH ME in upper stretch, dueled with the winner in the drive and finished gamely. NO MESA WITH ME , three wide both turns, chased the pace, bid for the lead between the top pair near the five sixteenths pole then weakened after being jostled between those rivals near the three sixteenths pole. REHOBOTH lacked speed, raced along the rail on the far turn and failed to rally. BANK OF DAD saved ground and was outrun. DISTRIBUTOR , wide entering the stretch, was not a factor. RASCAL CAT set the pace along the rail and faltered leaving the far turn. Objections by the rider of NO MESA WITH ME against PRIMARY WITNESS and KURBAT for alleged interference in upper stretch were not allowed.
