**Footnotes**

BEAU CHOIX saved ground on the first turn, stalked the pace two wide on the far turn, swung to the four path at the head of the stretch, swept to command inside the eighth pole, drew out under urging and his rider briefly dropped the left rein near the sixteenth pole. MANHATTAN FOX lacked speed, swung wide turning for home and rallied. CAT PARK , inside horses on the far turn, awaited room near the quarter pole, angled to the three path in upper stretch and finished willingly. THUNDER BREW , three wide both turns, gained the lead in upper stretch and weakened in the drive. SEE THE U S A , checked in a pocket midway on the first turn, raced very wide entering the stretch and was not a factor. BAILEYS BEACH was outrun. KERA'S KITTEN saved ground, dueled and faltered in upper stretch. PONZI SCHEME dueled two wide and faltered.
