

LICENSE FEE was taken to rate off of CRYSTAL SEA, lodged a bid between rivals nearing the furlong marker, took a short lead approaching the sixteenth pole, went clear then dug in gamely under steady handling to prevail. STARINE (FR) raced under snug rating while saving ground, steadily advanced approaching the quarter pole, swung out from behind rivals near midstretch, closed gamely and was getting to the winner. CRYSTAL SEA quickly went clear, set a slow pace along the inside, was collared in midstretch and gave way grudgingly. QUEUE was unhurried early, saved ground into the lane, angled out and rallied. COLSTAR settled off the rail, raced between rivals entering the lane, swung out very wide and lacked a solid response. MARIA'S TIARA was well placed along the inside down the backstretch, angled three wide midway on the final turn, made a run at the lead in upper stretch then faded in the final furlong. BATTENKILL raced wide to the head of the lane and tired. LAURICA raced off the rail and in a forward position for five furlongs then faltered.
