STAKES The Very One S. Black Type - Thoroughbred

FOR FILLIES AND MARES, THREE-YEARS-OLD AND UPWARD. By subscription of \$100. \$250 to pass the entry box. \$250 additional to start with \$50,000 Guaranteed, (plus \$25,000 for Registered Maryland Breds) of which 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. Unearned guaranteed purse money is split between the horses that start and finish the race. Supplemental nominations of \$500 each will be accepted by the usual time of entry with all other fees due as noted. Weights: Three Year Olds, 120 lbs.; Older, 124 lbs. Non-winners of \$60,000 in 2011 allowed 2 lbs.; of \$50,000 in 2011, 4 lbs.; of \$40,000 in 2011, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). Trophy to the owner of the winner. Nominations closed Tuesday May 10, 2011 with 31 nominations. (If deemed inadvisable by management to run this race on the Turf course, it will be run on the main track at Five Furlongs).

SUZZONA stalked the pace, circled the turn, was fanned four wide in upper stretch, sprinted clear in midstretch and lasted under urging. SUPREME lacked speed, raced wide on the turn, was fanned to the six path entering the stretch and rallied willingly. ROSE CATHERINE stalked the pace off the rail around the turn, was floated to the five path in upper stretch, advanced to midstretch then gave way in the drive. WHAT SHE SAID lacked speed, raced near the rail on the turn, angled out in upper stretch and passed tired horses. COLONY CLUB hugged the rail, was caught in narrow quarters in midstretch then weakened the final furlong. SEA WIND , in the seven path turning for home, was outrun. DON'TGETSUSPICIOUS dueled outside THREETIMESAWONDER, was floated out by that one in upper stretch then gave way. THREETIMESAWONDER saved ground disputing the pace, drifted out a bit in upper stretch and gave way in midstretch.
